**Faculty Positions Nominations/Vote**. Elections for 2012-2013 Faculty Chair, 2012-2013 Agenda Committee members, and 2012-2013 Faculty Advisory Panel on the College Budget members was held. The results will be announced at the next Faculty Meeting.

## Proposed Faculty Handbook Change.

Allen Olson facilitated the continuation of a discussion of a proposed changed to Section 2.300 of the Faculty Handbook concerning Academic Deans' Work, Deans' Desk Assignments, and Deans' Groups brought forward by the Academic Deans. He walked through a slightly revised proposal based on the prior faculty meeting discussion. The faculty were asked to consider separately three different elements of section 2.300:

- 1. Replace the paragraph that begins "The DEANS are…" from section 2.200 of the Faculty Handbook with the following: "The deans are faculty members charged with academic administration (see section 2.300)." This element of the proposal passed as written.
- 2. Insert a revised section on Governance Groups (formerly *Deans'* [or Governance] Groups from section 2.303) into section 2.200, just before section 2.210. This element of the proposal passed as written.
- 3. Replace section 2.300 Academic Deans with updated language, primarily to reflect current practice. Lengthy discussion ensued, particularly related to a proposed amendment to section 2.302 Academic Deans: Selection Process, first paragraph, to strike "regular, continuing" as follows: "Candidates for academic dean will be solicited from within the regular, continuing faculty in the fall of the year preceding their term, and a decision on those candidates will be made at least six months prior to the beginning of the term." The amendment failed by a vote of 12 in favor, 22 opposed and 13 abstentions. A motion to table the third item that in its entirety was made but not voted on.
