If you do not meet the federal definition of being independent as described in the *Free Application for Federal Student Aid (FAFSA, Section II)*, you may request that the Financial Aid Office make a waiver of your status on the basis of documented extenuating circumstances. To be considered for independent status, complete this form and attach all applicable documentation.

The decision to override a student's dependency status must be made on a case-by-case basis, justified by an individual student's unusual circumstances, and must be documented in the student's file. *The parent's unwillingness (vs. inability i.e. incarceration, institutionalization, etc.) to assist the student should not, in and of itself, be grounds for a dependency override.* Evergreen's Financial Aid Office will not automatically accept requests for independent status granted by another institution. Renewal of the dependency override is **NOT** automatic. When a request for independent status is approved, it is granted only for the specified academic year and must be reapplied for each year until the student meets the FAFSA guidelines as independent.

Basic Categories for Request	Required Documentation
Estrangement from parents	At least two letters of support documenting knowledge of the situation. ....At least one must be from a professional agency.
Parent's inability to provide financial support. An example of inability is incarceration.	*A letter from parent(s) addressing their inability to provide financial support, <b>and/or</b> ...documentation from the supervising agency, and/or ...the judgment of the court. and/or ...other documents as appropriate.
Student is on active military duty	Documentation indicating current military status
Student was previously married	1. A copy of divorce decree, marriage certificate or other documentation of marriage, <b>and</b> 2. A letter from parents stating that they are not providing any financial support.
Student has worked in a profession for at least one year after graduating from a professional, technical, or apprentice program.	1. A letter from employer(s) and a copy of diploma or certificate <b>and</b> 2. A letter from parents stating that they are not providing any financial support.
Other extenuating circumstances not described above	Documentation of situation
