Contract Description
For this contract entitled World and Ritual Dance as Transformative Agents , the student will learn the types and nature of the transformative experiences of ritual dances. In addition, she will learn the history of such dances and their efficacy, as well as explore ethnographic compilation formats and information flows. While studying transformative leadership, ethnographic studies, trance and ecstatic dance, she will further develop skills in dance instruction by teaching entry-level dance courses for the World Dance Organization. She will work closely with her Field Supervisor, Sarvani Cecilia, Director of the World Dance Organization.
The student will travel to Colorado, New Mexico and Montana to participate in and teach at dance events and she will write a journal of her experiences. She will conduct research and document Gypsy nation dances, give out questionnaires and record personal interviews at these events. Every other week she will provide an integrative art piece and submit a response paper to 2 books pertaining to ethnographic studies, transformative ritual, trance and ecstatic dance.

I will work closely with my field supervisor to plan my dance participation and dance courses in Colorado, New Mexico and Montana.
