### PURPOSE

The *National Native Master Artist Initiative: Artist Teaching Artists* program is designed to promote Native arts and cultures within urban and rural Native communities throughout the United States. The grant provides an opportunity for a Master Native Artist to teach other Native artists, whether established or emerging, within a community setting.

### ELIGIBILITY

The Longhouse is accepting letters of inquiry from both organizations and individuals. Organizations may apply for funds to support a Master Native Artist to be in residence for the purpose of teaching a form of visual or performing arts to Native artists within the community. Individual Master Native Artists may also apply to be a resident artist in a community.

#### ❖ **Definitions:**

- **Native** is defined as: American Indian, Alaska Native or Native Hawaiian; documentation of ancestry will be required for Master Native Artists.
- **Master Artist** is defined as: someone with a documented **ten year** history of producing and teaching their art.

#### ❖ **Organizations** are defined as:

- tribal governments
- urban Native centers
- educational institutions
- other organizations that work in support of Native arts and cultures

### APPLICATION PROCESS & DEADLINES

- 1) Special consideration will be given to residencies that will occur at The Evergreen State College or will directly influence the Longhouse communities at Evergreen.
- 2) The first step of the application process is a Letter of Inquiry, which provides a brief description of your project. The Letter of Inquiry materials deadline is **April 1, 2010**.
- 3) Those individuals or organizations invited to submit applications will be notified via e-mail or regular mail by **April 15, 2010**.

- 4) If invited to apply, the application deadline is **July 1, 2010**.
- 5) Grant Award Notifications will be made by **September 7, 2010**
- 6) Your project and a report must be complete by **December 31, 2011**. It is a requirement of the grant to report on the outcomes of your project. A one page narrative with four images will meet the reporting requirement.

## **PROJECT DETAILS**

### **Art Forms**

Proposals for **all forms of visual, performance, performing arts and literary arts** will be accepted.

### **Project Duration and Timeline**

Residencies do not have to be for extended periods; they could be an intensive one or two week training or could be for a longer time period, depending on the art form, the wishes of the artist or the needs of the community. Projects can begin upon notification of the award in September 2010 and must be complete by December 31, 2011.

### **Evaluation and Documentation**

All residencies funded under this initiative will be evaluated by participating artists using evaluation forms provided by the Evergreen Longhouse. We request that the residencies be documented by the host organization by photo or video. At the conclusion of the project, we request a photo essay from the host organization that can be published by the Longhouse to produce a catalog documenting the residencies

### **Number and Amount of Awards**

The Longhouse's Native Arts Advisory Board will select applicants who will be awarded up to \$5,000. Total project costs may exceed \$5,000 as long as other sources of funding are identified in the application.

## **LETTER OF INQUIRY GUIDELINES**

In addition to the **Letter of Inquiry Cover Sheet** (page 4), please submit a **Letter of Inquiry** that meets the following specifications:

- One typed page total
- Standard 1 ¼ inch margins
- 12 point font

The **Letter of Inquiry** must include the following information:

- ❖ Name, Native affiliation and artistic expertise of the proposed Native master artist
- ❖ Description of the proposed project and the art form to be taught

- ❖ Brief description of the host community (location, population, etc.)
- ❖ Host organization's mission statement
- ❖ Explanation of how the host organization's mission statement addresses Native art
- ❖ Evidence of previous successful programs with Native communities for the host organization and master Native artist
- ❖ Statement of why this project is needed in the host community.
