To Apply: Potential vendors must submit an application at least two weeks prior to the arts fair of their choice (Holiday Native Arts Fair or Super Saturday Native Arts Fair). You may submit your application via e-mail, fax or regular mail. Longhouse staff will contact you within two business days after you submit your application. The Longhouse upholds the Indian Arts & Crafts Act of 1990 (P.L. 101-644). Each applicant must provide documentation of Native heritage with this application.

Art Fair Details

- The Longhouse will provide each vendor with one to three tables and two chairs. The set up varies each year with each event. Please call for more details.
- Vendor tables are first come, first serve. Longhouse staff will not reserve specific tables for vendors.
- Vendors secure an arts fair table with a registration fee of \$50.00 paid by cash, check or money order. Booths are not guaranteed without paying the registration fee before the arts fair.
- Vendors are expected to sell their goods for the duration of the art fair from beginning to end.
- **Vendors must submit this application form to participate in the arts fair. Signing up over the phone is no longer an option.**

***THE INDIAN ARTS AND CRAFTS ACT OF 1990**

The Indian Arts and Crafts Act of 1990 (P.L. 101-644) is a truth-in-advertising law that prohibits misrepresentation in marketing of Indian arts and crafts products within the United States. It is illegal to offer or display for sale, or sell any art or craft product in a manner that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian or Indian tribe or Indian arts and crafts organization, resident within the United States. By participating in the Longhouse arts fair, you warrant and represent that you have complied with the Indian Arts and Crafts Act of 1990, as well as all other applicable laws and regulations pertaining to the sale of your products.
