

Summer 2024 Financial Aid Application, Policy, and Procedure

Complete and return the Summer Interest Form by *May 1, 2024.* If your interest form is late, it may not be processed before summer quarter begins. Be prepared to pay tuition with personal funds. Your budget and offers will be based on the number of credits and sessions you have indicated for which you intend to enroll.

Financial Aid Information for Summer Quarter

When you are applying for Summer 2024 Financial Aid, the 2023-2024 FAFSA is used to determine your eligibility. At Evergreen Summer is considered to be the last quarter of the academic year.

Summer Financial Aid typically consists of loans and a Pell Grant and Washington College Grant, depending on individual eligibility.

In order to receive financial aid for summer quarter, you must complete your summer registration (both 1st and 2nd sessions) by July 5, 2024.

Important Loan Information

The last day to accept Summer Loans for the first session is July 24, 2024, and for full or second session the last day to accept loans is September 2, 2024. Accept your loans as soon as you can after receiving a Summer Financial Aid offer. Your loans can be accepted on my.evergreen.edu. We cannot process loans after the session you are attending has ended.

Timing of Awards

The Financial Aid Office will begin making awards beginning the week of May 6, 2024 to students who submitted their Summer applications on-time by May 1, 2024.

Withdrawing from Summer Classes

Your summer registration will not be dropped if you decide not to attend. If you fail to drop your registration, you will be responsible for any charges that remain on your account including, but not limited to, tuition and fees, financial aid that has been returned, and interest that accrues due to an unpaid balance.

Have you filed your 2024-2025 FAFSA yet? The priority deadline is April 1st. You are awarded in the order in which your FAFSA was received. Watch your my.evergreen.edu account and respond to any information requests promptly.



Dear Student:

In order to be considered for financial aid for the Summer quarter, this form must be returned to the Financial Aid Office. The priority filing deadline is May 1, 2024. Forms received after August 12, 2024 cannot be processed.

Undergraduate students must register for at least 6 credits to be considered for financial aid. Graduate students must register for at least 4 graduate credits or at least 6 undergraduate credits to be considered for financial aid. If you are a graduate student enrolling in undergraduate credits, you must provide a form that is completed and signed by the graduate program, which indicates that you are fulfilling endorsements or prerequisites. *
